About the Program

This four-year degree program is designed to provide you with specialized knowledge and skills in international business. The degree-level program builds upon the solid foundation of a well-rounded management education including accounting, finance, marketing, human resources, ethics and strategy. As you move into the intermediate and advanced years, the BMI program emphasizes business and supply chain processes that cross international boundaries and focuses on the complexities of operating in an international environment. Application of business technology is integrated throughout the program to introduce students to enterprise resource planning concepts and techniques.

As a graduate of this program, you will also have the required knowledge to pursue several industry designations, and are eligible to apply for graduate studies at various institutions in Canada and internationally.

You will gain specialized skills and knowledge from faculty with extensive expertise in international business and from interactions with industry professionals. As a graduate of this program, you will be adaptable and ready to meet the challenges of an evolving global business environment.

Program and Course Delivery

This program is offered in Seneca's hybrid delivery format with some courses available in Seneca's flexible delivery format. Some coursework is online and some must be completed in person. Students will need to come on campus to complete in-person learning requirements. For courses offered in the flexible delivery format, professors use innovative learning spaces and technology to teach students in a classroom or lab and broadcast in real time to students attending remotely. In flexible courses, students have the choice of coming on campus or learning online.

Work Experience Mandatory Degree Co-op

A work experience that includes at least one term in a formal work environment. In most cases the work term(s) is a paid position that is completed between two academic semesters and requires a minimum of 420 hours of work. Students must be in good standing and meet all identified requirements prior to participating in the work experience. The successful completion of the co-op work term(s) is required for graduation. Eligibility for participation does not guarantee that a work position will be secured. Additional fees are required for those participating in the mandatory co-op stream regardless of success in securing a work position.

- Conduct environmental analyses to identify opportunities, threats, trends, and strategic uncertainties.
- Analyze and interpret business data for strategic and operational decision-making.
- Integrate appropriate technology to optimize business processes.
- Create plans for international business projects using project management tools and techniques to support achievement of organizational goals and direction.
- Compare international management approaches within the context of regulatory, ethical and legal environments that contribute to an organization's plans and processes.
- Develop strategies that integrate and acknowledge cultural diversity in an international setting.
- Build and manage interpersonal relationships and teams through effective communication, collaboration, negotiation, problem solving, and self-reflective practice.

Admission Requirements

- Ontario Secondary School Diploma (OSSD) or equivalent, including six Grade 12 U or M courses with a minimum overall average of 65%, or a mature applicant (https://www.senecapolytechnic.ca/registrar/ canadian-applicants/admission-requirements/mature-applicants.html).
- Required courses with minimum final grade of 65% in each:
 - English: Grade 12 ENG4U
 - Mathematics: any Grade 12 U
