

POLICE FOUNDATIONS (LAW)

About the Program

Prepare for an exciting career in law enforcement and crime prevention. In this two-year diploma program, you will gain a comprehensive education combining professional knowledge with practical skills development. This program prepares you a range of careers in public safety, policing, investigations, security and enforcement services in public and private organizations, and corrections.

Seneca's Police Foundations program uses hybrid and online delivery across our curriculum to deliver innovative and flexible learning focused on student needs. For the majority of courses, students can choose between online and in-class options to decide a delivery mode that works best for students and their timetables, while also concentrating on the applied and professional skills needed for successful careers in law enforcement and community safety.

Pathway to a Degree

Graduates of the Police Foundations program with a GPA of 3.0 or higher are eligible for advanced entry into semester four of Seneca's Honours Bachelor of Crime and Intelligence Analysis (<https://www.senecapolytechnic.ca/programs/fulltime/CIA.html>).#This provides an opportunity for students to enter and complete the degree within two years (or five semesters and a work term), after completion of the two-year diploma.

Police Selection

Applicants are advised that following graduation from Police Foundations, the selection process from Police Services in Ontario include:

- Canadian Citizen or Permanent Resident of Canada
- written aptitude and communications tests
- criminal records check
- physical fitness testing
- vision, hearing and medical tests

Program and Course Delivery

This program is offered online and is also available in Seneca's hybrid delivery format. With hybrid delivery, some coursework is online and some must be completed in person. Students choosing hybrid delivery will need to come on campus to complete in-person learning requirements.

After successful completion of Security & Crime Prevention, you can apply for a training completion number. It will make you eligible to be tested, at your own expense, for the provincially regulated licence to be a security professional.

- Conduct investigations by collecting, documenting, preserving and presenting admissible evidence.

Admission Requirements

- Ontario Secondary School Diploma (OSSD), or equivalent, or a mature applicant (<https://www.senecapolytechnic.ca/registrar/canadian-applicants/admission-requirements/mature-applicants.html>)
- English: Grade 12 C or U, or equivalent course

Canadian citizens and permanent residents may satisfy the English requirements for this program through successful Seneca pre-admission testing. (<https://www.senecapolytechnic.ca/registrar/canadian-applicants/admission-requirements/mature-applicants.html>)

Although not required for admission, completion of a secondary law course is recommended for your success in the program.

A moderate degree of physical fitness is required for the program.

International Student Information
